### **Early Pembroke Completion Marks a Powerful Performance from BAUER**

Works to install 2,250 Continuous Flight Auger (CFA) foundation piles for a new 2000MW state-of-the-art, Combined Cycle Gas Turbine Power Station near Pembroke has now been completed by BAUER Technologies Ltd, and well ahead of schedule.

The speed of progress and early completion of the project, works which were undertaken for Alstom on behalf of RWE Npower, is an endorsement of BAUER's CFA capabilities and in particular, its BG28 rigs, that by delivering the minimum 220kNm torque required for the complexities of the job, as well as being able to perform both rotary and CFA tasks, are almost without equal.

The excellent progress made on the job owed as much to site organisation as it did to the rigs, with BAUER Technologies receiving continuous high scores in Health & Safety Audits and the company's first ISO inspection, which was carried out on-site, led to the first accreditation being granted since being operational early in 2008. Other accreditations are expected before the end of the year.
